Monographic Services Division

July 1, 2010 - June 30, 2011

1. Major activities, accomplishments, significant changes and issues, grants and gifts

Conducted a second test of a UW version of the BIBCO Standard Record for textual materials and trained staff in preparation for implementation on July 1, 2011.

Began a pilot of demand driven acquisitions of e-books with YBP and EBL. Also contributed to planning for a similar pilot project through the Orbis Cascade Alliance. Completed a separate pilot with ebrary.

With Serials, led an ongoing project to load detailed holdings information into OCLC, including staff training for MARC checkin records, and planning for conversion of holdings records to MARC format and export of these records to OCLC.

Began a pilot project to catalog certain foreign language titles for other members of the Orbis Cascade Alliance as a test of shared technical services. Provided copy cataloging of books in Arabic for one other library.

As a result of ongoing refinements in procedures, achieved cataloging of 87% of print purchases in Monographic Acquisitions. Took steps to implement quick cataloging of music scores in Acquisitions.

Expanded the number of staff trained in media cataloging, including Julie Moede, Mary Whiting and Vincent Wilhite.

First unit to change from XP to the Windows 7 operating system, with testing and input from Division LEGs. Beta tested and installed a new version of the OCLC Connexion client throughout the Libraries.

Helped in the formulation of a pilot project in Interlibrary Lending to directly acquire selected titles when the cost of purchase is less than the cost of borrowing (Thrifty ILL). Continued to purchase titles requested by ILL for faculty and graduate students (Purchase ILL).

Completed changes in Innovative to allow records cataloged according to Resource Description and Access (RDA) to display in a better way. Began to accept RDA records in copy cataloging.

Began planning to store older documents in the sub-basement.

Continued work on a number of projects: cataloging of a large gift of VHS videos, the cloudseeding digital project in Monographic Acquisitions, and retrospective cataloging of U.S. government documents.

2. Major activities and initiatives anticipated for next year

Implement UW versions of the BIBCO Standard Record (BSR) in additional bibliographic formats: moving images, sound recordings, scores, maps, graphic materials, and electronic resources.

Train catalogers and other staff in the FRBR model in preparation for implementing RDA, and plan and begin some training for RDA itself. Conduct training in NACO and series headings for selected staff.

Begin a pilot of electronic theses and dissertations, including changes in workflow and training.

Continue to develop workflows for e-books in acquisitions and cataloging in response to changes in funding and purchasing models, such as demand driven acquisitions.

Participate in the Orbis Cascade Demand Driven Acquisitions e-book pilot and its likely extension.

Review the outcomes of the Libraries Acquisition and Licensing Review Group.

Catalog maps on a grant from the Friends of the Libraries.

Contribute to plan for a shared ILS system for the Orbis Cascade Alliance. Review local practices in light of a shared ILS.

Begin regular uploading of holdings to OCLC.
